


Viewing RSS Feeds With Mozilla Firefox



Subscribing To An RSS Feed Using Mozilla Firefox, Version 3

By the term *subscribe* we mean that your browser will bookmark the RSS-format page and will automatically reload it at periodic intervals in search of newly published information.



By clicking on the “Subscribe Now” button you will direct Firefox to both bookmark the RSS-format web page and to reload it at hourly intervals. **N.B.** If you wish for Firefox to reload the feed’s items at more frequent intervals then it is necessary to set a hidden preference. Consult the “Reloading Live Bookmarks” help topic on the Firefox web site.
